The undersigned

daje ovlast ovom punomoći:

hereby constitute and appoint:

da za njega / njih prijavljuje u Bosni i Hercegovini:

to act as his/their Agent in Bosnia and Herzegovina:

- a) patente za sve njegove / njihove izume, kao i dopunske patente.
- b) sve njegove / njihove žigove, uzorke i modele.

- a) in respect of any application for Patents of Invention, as well as for Patents-in-Addition.
- b) to apply for registration of any Trademark, Model and Design in his/their name.

Osobito punomoćnik ima ovlast da prima za potpisanog sva saopćenja, tužbe i druge dostave, da daje za njega / njih izjave da može voditi sporove kod Patentnog ureda Bosne i Hercegovine u Sarajevu, kao i kod sudova i svih drugih vlasti u svim krivičnim i građanskim stvarima i od njih odustajati; da može praviti prigovore, podnositi žalbe i druga pravna sredstva i od njih odustajati, pristajati na izborni sud, prisege nuditi i povraćene primiti; skrbiti o izvršenju presuda, sudska osiguranja tražiti i skidati, poravnati se, primati novac i novčane vrijednosti; od prijava i odobrenih prava industrijskog vlasništva odustajati; prenijeti ovu punomoć u cjelini ili djelomično i uopće sve poduzimati što po zakonima gore navedenih prava za potrebno i korisno bude našao.

In the execution of this Power of Attorney the said attorney is specially authorized and empowered to receive all communications, complaints and other notices; to give declaration in his/their name; to lodge complaints with the Patent Office of Bosnia and Herzegovina in Sarajevo, the courts and any other Authorities in any Penal or Civil Proceedings, or to withdraw the same; to raise objections; to appeal and to have recourse to other legal measures and to withdraw the same; to submit to arbitration; to offer and to accept oath; to attend the execution of sentences; to apply for judicial securities and to cancel the same, to compromise; to receive money and other valuables; to withdraw any application and any registered right of industrial property, to substitute all or any part of the present power; and to do generally all that may be necessary according to the laws to secure the grantor of the privileges above mentioned
